ALL ARTISTS WILL BE JURIED, regardless of acceptance to previous shows. Artist must submit three (3) photographs per category of work to be displayed. Please Indicate top of photo and have name on back of each.

Artwork must be original in design. Each artist must be present with and display their original work for the entire day of the show; only artwork in the category that was accepted may be displayed. Artists who fail to appear after reserving a space, or those artists who leave prior to the close of the show, may be denied participation in the next Art for All show. No commercial dealers, agents, kits, crafts, or castings from commercial molds may be displayed or sold at the show. Art for All Inc. committee members will visit booths throughout the show to ensure compliance with these rules. Artists violating these rules shall be required to remove all work not in compliance. Artists in violation may be asked to leave the show. There shall be no refunds for an artist asked to leave the Art for All grounds. Artists are responsible for sales tax.

DISPLAY AREA: 12' x 12' outdoor space to display your merchandise. Only one artist per booth. Art For All, Inc does not supply tents, tables, or chairs.

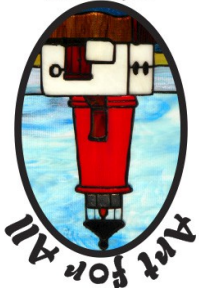
